Client is aware and clearly understand that Hunt New Zealand will not have liability regarding provision of medical care or adequacy of any care that may be rendered. The Client hereby waves and releases any and all claims against Hunt New Zealand for personal injury, property damage, accident, delay, inconvenience, change in itinerary or accommodation, or other irregularity, which may occur due to, but not limited to:

1. Wrongful, negligent, or arbitrary acts of omission on the part of supplier, their employees or others not under direct control of Hunt New Zealand.
2. Defects or failures of any conveyance, equipment, or instrumentality under the control of the supplier.
3. Acts of God, fire, acts of government or other authorities, wars, civil disturbances, riots, strikes, thefts, pilferage, epidemics, quarantines or dangers incident to the sea, land or air, and...
4. All risks which arise from Clients participation in all travel activities.

The Client acknowledges and assumes these risks with understanding that activities participated in as requested by the Client, have inherent dangers from either hunting, riding, fishing, shooting, travel or otherwise.
